RE: Alternative Restoration Plan Approval for North Branch Deerfield River

Dear Ms. Sargent:

Thank you for submitting the Mount Snow Water Quality Remediation Plan to EPA for acceptance as an alternative restoration plan for the North Branch Deerfield River. The North Branch Deerfield River was placed on the CWA Section 303(d) list of impaired waters in 2004 due to an aquatic life impairment caused by stormwater runoff. The remediation plan includes an analysis of stormwater/sediment loading, the reduction needed to meet water quality standards, and specific actions needed to achieve that reduction.

Consistent with the EPA memorandum from Benita Best-Wong, dated August 13, 2015, with the subject line, "Information Concerning 2016 Clean Water Act Sections 303(d), 305(b) and 314 Integrated Reporting and Listing Decisions" and the EPA TMDL Vision framework ("the Vision")¹, the submitted plan was written to inform and guide pollutant load reduction implementation. The plan includes the relevant elements specified in these memoranda and we accept the Mount Snow Water Quality Remediation Plan as an alternative restoration plan to be counted towards WQ-27, which is a performance measure used to track progress in implementing the CWA 303(d) Program Vision, for FY2021.

We are pleased to acknowledge that this plan has already led to the successful restoration of the stormwater impairment to North Branch Deerfield River. This impairment cause was removed from the Vermont Section 303(d) list of impaired waters approved by EPA in 2020.

Thank you again for your submittal of this plan.
