Certificates & Technical Curriculum Supported by EPA	<p><u>Curriculum One/Asbestos Remediation Program:</u> Curriculum is geared towards Brownfields assessment and cleanup, mainly focusing on asbestos remediation. The presence of a Fort Lyon EWDJT program will create needed vocational and employment opportunities, increasing the number of locally trained technicians. Brownfields assessment and cleanup, focusing on asbestos remediation, and wastewater treatment. Fort Lyon has a vast array of Brownfields sites, with asbestos as the primary hazardous material present. We have been working with the EPA since 2017 to assess and clean these sites, and we plan to continue this work for the foreseeable future, as funding allows.</p> <p><u>Curriculum Two/CDL Program:</u> Fort Lyon hosts a tri-county regional transit system that could complement the stated need for Commercial Driver’s Licenses (CDLs) for transporting hazardous materials. If funded, the Fort Lyon EWDJT program will leverage available infrastructure to provide hands on training to participants through contracted trainers as overseen by an Advisory Board made of local experts, trainers, and employers to ensure successful graduate placement. Curriculum Two/ CDL Program will leverage the existing capacity to study for and test to receive CDLs hazardous waste removal through the Bent County transit system in response to employer need. The transit system serves the entire LAV and was created to connect SRC residents to the mental/behavioral/medical care providers off campus. The transit system will work with DOLA, BCDF, & SECO SBI to provide training opportunities to participants as well as provide funding for training stipends, in addition to the EPA EWDJT funding. EWDJT funds will support training, physical and vision screening, and certification costs of the CDL. EWDJT staff will track which employment opportunities require a CDL to transport hazardous material to ensure program graduates meet available employment requirements, ensuring successful placement.</p> <p><u>Curriculum Two/Wastewater Management Training Program:</u> Brownfields assessment also focuses on wastewater treatment. All the local wastewater treatment facilities partner with Colorado Rural Water Association (CRWA) to conduct the necessary training for staff. To avoid duplication, we utilize CWRA’s training infrastructure to complete training for the Fort Lyon EWDJT as well. The Fort Lyon EWDJT program will leverage the wastewater treatment facility onsite to offer trainings through the CWRA as dictated by local employer demand. This training will assist with the placement target of general technicians for city or county-owned wastewater facilities and allows the Fort Lyon EWDJT to meet ongoing local employer</p>

	needs by utilizing local and trusted expertise.
Additional Skills and Services	<p><u>Wastewater/Water Systems curriculum expansion:</u> Discussions with CRWA (Colorado Rural Water Association) are already forming program expansion. Deciding to grow from a 2-week wastewater training course into further advanced wastewater training & programs for wastewater management and water systems. Also discussing expanding into an apprenticeship program concerning wastewater management and water systems.</p> <p><u>Additional Life Skills:</u> SECO SBI will be housed on the Fort Lyon campus by early Spring 2022 and is assisting BCDF and DOLA with EWDJT program management and implementation. There is opportunity for EWDJT program graduates to gain business soft skills thru the SECO SBI, resume building, computer literacy webinars, incubation of businesses they may form after training(s) and gain further business consulting assistance onsite. There is also a current collaboration with SECO SBDC, CU-Denver, and SECO SBI to house a Rural High-Tech Hub on the Fort Lyon campus. EWDJT graduates can gain data science certification & further data science course knowledge if they choose.</p>
