



Top 30 On-site Generation

As of October 22, 2024, the combined annual green power use from EPA Green Power Partners using onsite sources amounts to more than 1.5 billion kilowatthours of green power, which is equivalent to the annual electricity use of nearly 141,000 average American homes.
